**Purpose:**

To ensure the understanding of all parents and players the costs associated with participation on the Nova Major Hockey Team. By signing the 2023-2024 Nova Scotia Major Hockey League Registration Form or the 2023-2024 Nova Scotia U15 Major Hockey League Special Affiliation Form, the registrant (parent or legal guardian) acknowledges and accepts the following policy.

**Policy:**

**Player Registration Fees**

- The registration fee for the 2023-2024 hockey season is \$3,200 per player. The registration fee can be paid in full or in installments to the team. The registration fees can be paid in cash, cheque, or electronic transfer of funds. Installment dates are as follows:

Only after the first registration installment has been paid in full will a player receive the necessary equipment and be allowed to participate in Nova Scotia U15 Major Hockey League games.

- The registration fees cover:
  - Qualified & Certified Coaching Staff
  - 2-3 practices per week
  - 17 home games
  - Tournament Registrations
  - Player name bars for the back of both home and away jerseys
  - A numbered & named warm-up suit with team emblems
  - Banquet & Awards night which is held at the end of every season.
  - Each player will receive one pair of team gloves and a team helmet & mask during his/her tenure with the team, which must be cared for in accordance with the team's Equipment Policy.
- Any person whose has a cheque returned by the bank for any reason will be notified and the player will be forbidden to take part in any team activity until the registration fee along with an additional \$25.00 fee is paid in full.

### Affiliate Player Registration Fees

- The registration fee for the 2023-2024 hockey season is \$500 per affiliated player. The registration fee can be paid in full or in installments to the team. The registration fees are to be paid in cash or by cheque. Installment dates are as follows:

Only after the first registration installment has been paid in full will the player be registered and an affiliate with The Novas and be allowed to participate in Nova Scotia U15 Major Hockey League games.

- The registration fees cover:
  - Qualified & Certified Coaching Staff
  - 2-3 practices per week
- Any person whose cheque is returned by the bank for any reason will be notified and the player will be forbidden to take part in any team activity until the registration fee along with an additional \$25.00 fee is paid in full.

### Refunds

- A request for refund must be made in writing to the Board of Directors of the Nova Major Hockey Team.
- A refund may be requested up until December 31<sup>st</sup> of the current hockey season.
- A refund due to a major injury may be accepted after December 31<sup>st</sup> for consideration by the Board of Directors, in cases where the incident occurred before the end of the year and the player is unable to return for the balance of the season.
- Refunds will be granted according to the date the request is received by the team.  
**Note:** Hockey Canada Insurance, Hockey Nova Scotia registration and Nova Scotia U15 Major Hockey League registration are 100% non-refundable, once a player has taken part in any Nova Major Hockey Team activity.
- If a player has participated in any Nova Major Hockey Team activity, a refund will be granted as per the following:
  - Prior to October 31<sup>st</sup> – 80% of the registration fee is refunded.
  - Prior to November 30<sup>th</sup> – 75% of the registration fee is refunded.
  - Prior to December 31<sup>st</sup> – 50% of the registration fee is refunded.

- After December 31<sup>st</sup> – No refund
  
- There will be no registration refunds for any players under suspension from Hockey Canada, Hockey Nova Scotia and/or the Nova Scotia U15 Major Hockey League.
  
- In accordance with the team's Equipment Policy, no refund will be granted to any player in their first year of eligibility with the team, until all equipment is returned to the hockey team.
  
- Try-out fees are non-refundable.
